#### NEW TOBACCO RETAIL LAW

### PROHIBITED TO SELL FLAVORED TOBACCO

Starting December 21, 2022, California law prohibits the sale of most flavored tobacco products including, menthol cigarettes, flavored e-cigarettes, little cigars, and flavored tobacco enhancers.



#### PROPER DISPOSAL

Flavored tobacco products must be removed from store shelves by Dec 21, 2022.

## \$250 FINE PER VIOLATION

\$250 fines apply to retailers and/or their employees who sell, offer to sell, or possess with intent to sell a flavored tobacco product.
